Data democratization empowers citizens, irrespective of technical expertise, fostering informed decision-making for equitable, sustainable, and responsive development. Spotlighting the use of public intent data, the discussion explores better utilization, addressing structural and technological challenges. Emphasizing creative deployment for efficiency and accountability, the panel tackles challenges and intentions of data democratization from both the demand and supply side, while examining existing gaps in data capacities.

Gender equality, social equity and inclusivity in development (Organized by IWWAGE and PCI)

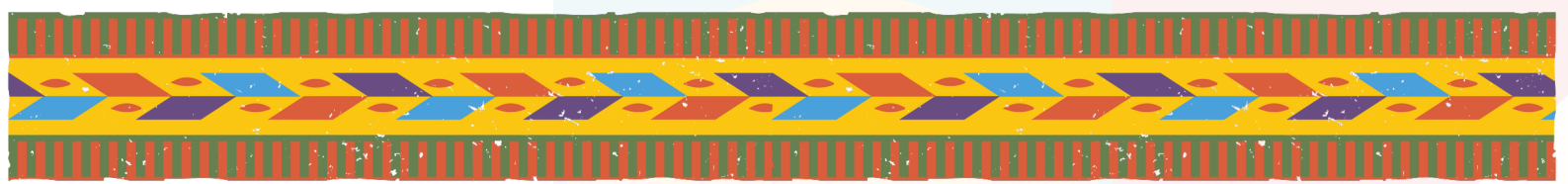

Institutionalization of National Evaluation Capacities: Learning from Youth Networks (Organised by EvalYouth India)

The recent 4th APEA conference called for action for institutionalisation of M&E for achieving the SDGs through the Manila Declaration. Previously in 2016, the Colombo declaration called for institutionalisation of evaluation within parliaments. In 2013, the participants at the National Evaluation Capacities conference developed and signed 18 commitments to enhance national evaluation capacities and to encourage accountability by calling participant countries to commit to actions and collaboration. The Global evaluation agenda was adopted in 2016. A lot of such calls to action have been made in recent times, but very little real progress has been made in India through concrete action. Through this roundtable, we wish to invoke ideas from YEEs about contextualising these different commitments and developing an action agenda for India.
